In the wake of the financial bungling controversy, Arvinder Singh Micky was appointed chairman of the JKCA scam probe committee. After even preliminary investigation, he said, "Something is fishy as the committee was not getting required cooperation from senior officials to investigate the scam. The way some senior officials of the JKCA are protecting tainted persons substantiates allegations that there is some sort of an understanding between higherups and those who are involved in the bungling of funds from the JKCA." He even lamented that corruption had crossed all limits.

In the JKCA cricket scam, Rs. 24.64 crore, meant for cricket activities in the state, was allegedly siphoned off by creating bogus accounts in the Jammu and Kashmir Bank Limited. It soon became a big

political issue as well. The BJP state president Shamsher Singh Manhas along with other party leaders observed a 48-hour satyagraha, demanding a CBI probe into the scam. It came to light that the Congress-led Government was not interested in probing this scam forcing Manhas to launch the satyagraha. He said the BJP had decided to rake up the JKCA scam issue at the nationallevel to expose the UPA government's encouragement to corruption.

The Enforcement Directorate (ED) case is based on an FIR filed by the CBI, which has booked former JKCA office-bearers, including general secretary Mohammed Saleem Khan and former treasurer Ahsan Ahmad Mirza. The CBI later filed a charge sheet against Farook Abdullah, Khan, Mirza, Mir Manzoor Gazanffer Ali, Bashir Ahmad Misgar and Gulzar Ahmad Beigh (former accountant of JKCA) for the misappropriation of JKCA funds amounting to Rs. 112 crore from grants given by the BCCI to develop infrastructure and promote the willow game in

the state between 2002-11. The ED said its probe found that JKCA received Rs 94.06 crore from BCCI in three different bank accounts during financial years 2005-2006 to 2011–2012. From the laundered funds, Rs. 1.31 crore was received by Gazanffer, who was part of the finance committee "arbitrarily constituted" by Dr. Abdullah as the ssociation president.
