Govt removes airfare caps imposed on airlines

New Delhi, Aug 14: The Union government on Wednesday said that it has decided to remove airfare caps imposed on airlines with effect from August 31, 2022 providing domestic carriers full freedom in fixing ticket prices.

"After review of the current status of scheduled domestic operations viz-a-viz passenger demand for air travel in terms of purpose specified in the initial order No. 02/2020 dated 21.05.2020, it has been decided to remove the fare bands notified from time to time regarding the airfares with effect from 31.08.2022," Civil Aviation Ministry said in its order on Wednesday.

Aviation Minister Jyotiraj Scindia said that the decision to remove air fare caps has been taken after careful analysis of daily demand and prices of



air turbine fuel.

"Stabilisation has set in & we are certain that the sector is poised for growth in domestic traffic in the near future," Scindia tweeted.

As an extraordinary measure during the Covid pandemic, the government had in 2020 notified fare bands for economy tickets on domestic routes.

The move was aimed at ensuring airlines do not charge excessive fare on one hand and also to ensure that the journey is performed only for essential purposes. While lower price band protected financially weak airlines, the upper price band of tickets shielded passengers from excessively high

fares by air-carriers. In its order, the Aviation Ministry has however directed the airlines to ensure that the guidelines to contain the spread of Covid are strictly adhered to and Covid appropriate behaviour is enforced during travel.

Ranveer Singh summoned by Mumbai Police

Mumbai, Aug 14: Mumbai Police on Friday issued summons to actor Ranveer Singh on the charges of obscenity after his nude photographs appeared on social media.

Ranveer Singh has been asked to appear before the Chembur police to record his statement on August 22.

According to Mumbai Police sources, a team of Mumbai Police visited his residence to serve him a notice, but police learnt that he was not present at his residence, in fact, he is out of town, after which police tried to contact him to serve notice.



The Mumbai Police had July 26 registered an FIR against Singh over his nude pictures on social media. A Mumbai-based Non-Governmental Organisation (NGO) had approached the Chembur police here with a complaint

against the actor. Based on it, the police registered the FIR against Singh under various Indian Penal Code Sections like 292 (sale of obscene books, etc), 293 (sale of obscene objects to young people), 509 (word, gesture or act intended to insult the modesty of a woman) and provisions of the Information Technology Act, an official from the Chembur police station said.

An office-bearer of the NGO had alleged that the actor hurt the sentiments of women in general and insulted their modesty through his photographs, police earlier said.

'Psycho' actress Anne Heche legally dead

Los Angeles, Aug 14: US actress Anne Heche has been announced "legally dead", however, she will continue to remain on life support to allow possible organ donation, her representative told media.

The 53-year-old cult-horror "Psycho" remake actor was in coma for a week after crashing her car into a house here.

"Today we lost a bright light, a kind and most joyful soul," her family said in a statement on Friday.

Heche appeared in films including "Volcano", "Donnie Brasco" and the 1998 remake of Alfred Hitchcock's cult-thriller.

Mother-of-two, Heche also appeared on "Dancing with the Stars" in 2020.



According to the Los Angeles Fire Department (LAFD), Heche's vehicle "erupted in heavy fire", which took 59 firefighters more than an hour to fully extinguish. The two-storey home which she crashed into was left "uninhabitable".

Apart from suffering burns, the

actress was left with "a severe anoxic brain injury" - deprived of oxygen - the BBC quoted her family as saying.

A representative said the late actress is "legally dead," but added that her life-support treatment will continue temporarily to check if she may be a match for a potential organ donation.

"Anne will be deeply missed but she lives on through her beautiful sons, her iconic body of work, and her passionate advocacy," her family's statement said.

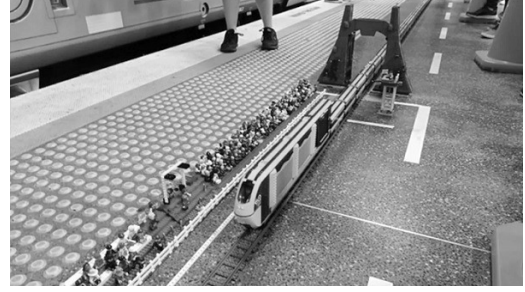

Fun Facts! Lego train with 101 cars breaks record

New Zealand, Aug 14: As a whopping record a New Zealand teenager earned a Guinness World Record when he used Lego pieces to build a toy train with 101 cars.

Alexander Blong, 14, of Auckland, said he was inspired by his boredom during COVID-19 lockdowns and the series Snow piercer to attempt to build a Lego train with 101 cars.

"I was bored, as most people were, and watching Netflix. There was this show I really liked called Snow piercer, which was about this really long train that goes around the globe," Blong



told The Guardian. Blong said it took him about 50 hours to build the 82-foot-long train. His creation earned the

Guinness World Record for most carriages in a toy train, beating the previous record by 32 carriages.

"This is truly incredible and inspires me to dream and create bigger projects," he told Guinness World Records.

Top girl groups to heat up K-pop chart race

Seoul, Aug 14: The K-pop industry is bracing for a heated chart race as some of the top girl groups are gearing up to throw their hats in the ring with new albums in August.

BLACKPINK, the most-followed musical act on YouTube, will return with a new single titled "Pink Venom" next Friday at 1 p.m., making it the band's first group project with all four members after one year and 10 months.

The song will be included in "Born Pink," the band's second LP set to come out on September 16.

After the new release, BLACKPINK will begin a mega world tour in October. The



"Born Pink" world tour will kick off in Seoul from October 15-16 and continue in North America, Europe, Asia and Oceania until June next year, the Yonhap

news agency reported. BLACKPINK was recently busy shooting the music video for the pre-release song, for which "the highest production cost ever was spent" according to its agency, YG Entertainment.

TWICE will return on August 26 with its 11th EP "Between 1&2." Not much is known about the forthcoming album. The last album participated by all of the group's nine members was "Formula of Love: O=1=3", its third full-length album that debuted at No. 3 on the Billboard 200 main albums chart following its release in November.

2. Global supply chain was disrupted due to Covid 19 earlier & due to Ukraine War recently, this has impacted our business.
